On 04/19/11, Ofc J. Walsh reports: On 04/19/2011 at approximately 0002 hours I responded to the location of in reference to a lewd and lascivious act on a three year old juvenile. Upon arrival I made contact with the mother of the juvenile victim, stated the following information in a sworn written statement.

stated that her son (child victim), date of birth was laying on the couch with James B. Jones (arrestee), watching television at the above address. was sitting on another couch located in the family room watching television with and Jones. stated that Jones and the child victim had a blanket covering them while they were on the couch. While watching television with and Jones. stated that Jones and the child victim had a blanket covering them while they were on the couch. While watching television with and Jones. Stated that Jones are laying on the child victim and Jones were laying. Stated that it appeared the hand movement was from Jones to the child victim and in the area of the child victim's penis. Stated that she immediately picked up the child victim and took him to his bedroom. So noticed that the child victim had an erection as she was carrying him to his room. Advised that due to the odd behavior of Jones she questioned the child victim about what she just observed on the couch. Stated that she asked the child victim if Jones had touched his private area and he replied "Yes, and I touched his pee-pee too." wishes to press charges.

advised that after telling the child victim's stepfather, what had occurred confronted Jones in reference to the incident.

advised that Jones denied the allegations and had never touched like that. Jones then ran from the residence in a unknown direction of travel.

On 04/19/11, at about 0934 hours, patrol officers made contact with Jones in the area of the residence. Jones was taken into custody at my request. Jones was read his Miranda rights and waived these rights, agreeing to speak with me. Jones admitted to touching the child victim's penis with his hand, but stated it was not on purpose. Jones also advised that the child victim touched his penis and again, placed the blame on the child victim. Jones was transported to the John E. Polk Correctional Facility without incident.

On 04/19/11, during a sworn statement taken during an intake interview with six, it was found that the clearly observe Jones' right arm terminate under the blanket in the area of the child victim's groin and observed an up and down motion of Jones' arm/hand, described and a masturbation movement. She also observed the same movement in the area of Jones's groin and was too large of a hand or object to be the child victim's arm.

On 04/19/11, during a forensic interview at the Kid's House, the child victim disclosed that his "private parts" penis was touched by "J" Jones, under his diaper and that he touched "BJ's" private parts while lying under the blanket.
