DUI AND SERIOUS BODILY INJURY TO ANOTHER

THIRD DEGREE

The defendant (D-1) was traveling south on Overland Road north of Beggs Road in a left curve in the roadway. D-1 indicated that she attempted to pass a passenger van in front of V-1 that began to slow down. D-1 drove across the double yellow lines then lost control as it reentered the northbound lane. V-1 rotated counterclockwise as it traveled in a southeasterly direction across the roadway and onto the east shoulder colliding with a mailbox. V-1 continued out of control traveling in a southeasterly direction into a secondary collision striking a concrete culvert. At secondary collision with the culvert, V-1 rotated counterclockwise into a third collision with its right rear passenger door striking a tree. At impact with the tree, V-1 overturned onto its roof and came to final rest just south of the tree facing northbound.

While on the scene, the Florida Highway Dispatch called us to report to Florida Hospital South (Orlando), regarding an occupant of the vehicle involved in the crash. Dispatch advised the occupant was being "very hostile and belligerent". The information was provided to dispatch by employees at the hospital. Trooper Daniel Mintz responded to the hospital to handle the situation. (See attached FHP Offense Report # FHPD110FF033564).

After completing the measurements and evidence recording at the scene, Sergeant Raymond C. Koenig and I went to the hospital to interview the defendant. The defendant was located on room #12 at the Florida Hospital Emergency Room. On my arrival I observed a young black female on the bed with several injuries on her face and body. I identified myself and told her that I was the Traffic Homicide Investigator in charge of the fatality investigation. At that time she spontaneously told me I can take her to jail because she killed her daughter and that she had been drinking. I explained the defendant that I needed to do a sworn interview with her, which she agreed. While I was in the room, I observed that she had blood shoot and glassy eyes. Also I can smell a strong odor of alcoholic beverage coming from her mouth.

I proceeded with the sworn interview and read Miranda Warning to the defendant and she agreed to answer my questions without an attorney. She stated that she was traveling southbound on Overland Road and she attempted to pass another vehicle on a curve (no passing zone). She stated that she lost control of the vehicle and struck a tree. She also stated that she did not remember her speed, but the vehicle in front of her was traveling slow. I asked her there was other traffic involved on the crash and she replied that there was no other vehicle involved.

I asked her if she had anything to drink or eat. Her reply was I had a cup and a half of "Crown Royal" and Coke. I asked if "Crown and Coca Cola" and she replied, "NO, I did Crown Royal and Cocaine". She also stated that she hadn't had anything to eat in 3 days. During the interview the defendant was belligerent and requested that I should take her to jail. At that time, I proceeded to conclude the interview and allow the nurses to take care of the defendant.

A blood sample from the defendant was sent to FDLE Crime Laboratory for testing. The blood test on D-1 indicated D-1 had a blood alcohol level of 0.244 grams of alcohol per 100 millitters of blood. The BAC level of 0.244 is above the legal limit of 0.08, which Florida Statute states is prima facie evidence of alcoholic impairment for vehicle operators. D-1's ability to perceive and react to events occurring around him was diminished by her consumption of alcohol.
