This lewd act was committed in the presence of multiple victims under sixteen years of age. BACKGROUND: On June 11, 2012 at approximately 1343 hours, Deputy Lisa Brown (1862) and Corporal Stan Waller (1673) responded to the Animal Kingdom Lodge located at 2901 West Osceola Parkway in reference to an exposure. Upon arrival they met with Disney Security who advised them a white male was exposing himself to young girls in the pool that is located in the middle of the hotel. They met with victims and along with their parents. INVESTIGATIVE DETAILS: On June 11, 2012 I was the on call Sex Crimes Detective for the Orange County Sheriff's Office. At approximately 1513 hours, I was contacted by the Orange County Communications Center in reference to this call. I spoke with Corporal Stan Waller and immediately responded to the Animal Kingdom Lodge. On June 1, 2012 at approximately 1602 hours, I arrived at the Animal Kingdom Lodge along with Detective Ben Thorpe (3680). I met with the victims and their parents in a private area inside the hotel. Detective Thorpe spoke with suspect John Oldham to obtain his personal information to include: name, date of birth, etc. While he was speaking to Oldham I walked each victim out to the main area and asked them if they saw anyone in the area they could identify. The room was full of different people and hotel guests were walking in and out. At approximately 1632 hours, , immediately identified a man with white hair, wearing pants and a light shirt as the man that exposed himself to her. victim 1. and at approximately 1636 hours, I brought her out to the same area and she I explained the same thing to victim 2 immediately pointed over to a male with white hair wearing a "bluish" shirt as the man that she saw "show his bathroom part" to her. On June 11, 2012 at approximately 1639 hours, I conducted a sworn digitally recorded interview with victim 1 . Before speaking on the allegation, I qualified that understood the difference between telling the truth and lying and the consequences of the latter. promised to tell the truth, not make anything up and to correct me if I said anything she knew to be false. It should be noted that is nine years of age and while speaking to her, it was clear to me that her intelligence level is commensurate with her age. The ' digitally-recorded, sworn statement: stated she is nine years old and is going into the fourth following is a synopsis of grade next year. She is visiting Disney with her family and is staying there for a week at the Animal Kingdom Lodge. advised she was swimming in the pool area of the Animal Kingdom Lodge Hotel near the slide when she "almost swam into an old man." advised she had goggles on and was diving in and out of the water. She went through a group of people and noticed the man standing in the water. One side of his swim trunks, which she described as red, white and blue "like an American Flag, but just parts of it" was pulled up near his waist and something was hanging out of the side on his leg. advised it looked like a "dog chew toy." She looked under water again because she wasn't sure what she saw, but when she looked again she knew it was his "private." We discussed private parts advised it was a "penis." She advised the other side of his swim trunks were down "like normal near his on males and females and knee " advised she thought it was "disgusting" so she went and told her parents. She advised while she was telling her parents, another family heard them and told them their daughter just came and told them the same thing. advised that her family did not know the other family and they had just met when this happened. They all began watching the man for a while and noticed him going near described the man as being in his forties or fifties, having gray hair. His swim trunks were red, white, and other girls in the pool. blue. He was tall and skinny. advised the man did not say anything to her. A copy of digitally-recorded interview was put on compact disc and placed in evidence. On June 11, 2012 at approximately 1652 hours, I conducted a sworn digitally recorded interview with victim 2 . Before speaking on the allegation, I qualified that understood the difference between telling the truth and lying and the consequences of the latter. promised to tell the truth, not make anything up and to correct me if I said anything she knew to be false. It should be noted that is seven years of age and while speaking to her, it was clear to me that her intelligence level is commensurate with her age. The following is a synopsis of digitally-recorded, sworn statement: advised she is seven years of age and visiting Disney World with her family. She is staying with her family at the Animal Kingdom Lodge. On today's date, she was spending the day at the pool with her family advised she was in the pool with her goggles on and was swimming by an older man with gray hair. She went under water and noticed his "private" was out of his swim shorts, which she described as "blue, white, and red shorts." I asked what she meant by his "private" and she advised it was his "bathroom part." I asked what comes out of the "bathroom part" she saw and she advised "pee." advised the bathroom part was "in the middle and kind of on the side" of his shorts.
