NARRATIVE: The undersigned has probable cause to believe the above-named defendant on the, 11 of June 2012 at 1:00 PM at 2901 W OSCEOLA PY (Zone: 61 ) in Orange County did

commit the offense of Lewd or Lascivious Exhibition by intentionally exposing his penis out of his swim shorts in a lewd manner. This lewd act was committed in the presence of multiple victims under sixteen years of age. BACKGROUND: On June 11, 2012 at approximately 1343 hours, Deputy Lisa Brown (1862) and Corporal Stan Waller (1673) responded to the Animal Kingdom Lodge located at 2901 West Osceola Parkway in reference to an exposure. Upon arrival they met with Disney Security who advised them a white male was exposing himself to young girls in the pool that is located in the middle of the hotel. They met with victims [REDACTED] and [REDACTED] along with their parents. INVESTIGATIVE DETAILS: On June 11, 2012 I was the on call Sex Crimes Detective for the Orange County Sheriff's Office. At approximately 1513 hours, I was contacted by the Orange County Communications Center in reference to this call. I spoke with Corporal Stan Waller and immediately responded to the Animal Kingdom Lodge. On June 1, 2012 at approximately 1602 hours, I arrived at the Animal Kingdom Lodge along with Detective Ben Thorpe (3680). I met with the victims and their parents in a private area inside the hotel. Detective Thorpe spoke with suspect John Oldham to obtain his personal information to include: name, date of birth, etc. While he was speaking to Oldham I walked each victim out to the main area and asked them if they saw anyone in the area they could identify. The room was full of different people and hotel guests were walking in and out. At approximately 1632 hours, victim 1, [REDACTED], immediately identified a man with white hair, wearing pants and a light shirt as the man that exposed himself to her. I explained the same thing to victim 2 [REDACTED] and at approximately 1636 hours, I brought her out to the same area and she immediately pointed over to a male with white hair wearing a "bluish" shirt as the man that she saw "show his bathroom part" to her. On June 11, 2012 at approximately 1639 hours, I conducted a sworn digitally recorded interview with victim 1 [REDACTED]. Before speaking on the allegation, I qualified that [REDACTED] understood the difference between telling the truth and lying and the consequences of the latter. [REDACTED] promised to tell the truth, not make anything up and to correct me if I said anything she knew to be false. It should be noted that [REDACTED] is nine years of age and while speaking to her, it was clear to me that her intelligence level is commensurate with her age. The following is a synopsis of [REDACTED]'s digitally-recorded, sworn statement: [REDACTED] stated she is nine years old and is going into the fourth grade next year. She is visiting Disney with her family and is staying there for a week at the Animal Kingdom Lodge. [REDACTED] advised she was swimming in the pool area of the Animal Kingdom Lodge Hotel near the slide when she "almost swam into an old man." [REDACTED] advised she had goggles on and was diving in and out of the water. She went through a group of people and noticed the man standing in the water. One side of his swim trunks, which she described as red, white and blue "like an American Flag, but just parts of it" was pulled up near his waist and something was hanging out of the side on his leg. [REDACTED] advised it looked like a "dog chew toy." She looked under water again because she wasn't sure what she saw, but when she looked again she knew it was his "private." We discussed private parts on males and females and [REDACTED] advised it was a "penis." She advised the other side of his swim trunks were down "like normal near his knee." [REDACTED] advised she thought it was "disgusting" so she went and told her parents. She advised while she was telling her parents, another family heard them and told them their daughter just came and told them the same thing. [REDACTED] advised that her family did not know the other family and they had just met when this happened. They all began watching the man for a while and noticed him going near other girls in the pool. [REDACTED] described the man as being in his forties or fifties, having gray hair. His swim trunks were red, white, and blue. He was tall and skinny. [REDACTED] advised the man did not say anything to her. A copy of [REDACTED]'s digitally-recorded interview was put on compact disc and placed in evidence. On June 11, 2012 at approximately 1652 hours, I conducted a sworn digitally recorded interview with victim 2 [REDACTED]. Before speaking on the allegation, I qualified that [REDACTED] understood the difference between telling the truth and lying and the consequences of the latter. [REDACTED] promised to tell the truth, not make anything up and to correct me if I said anything she knew to be false. It should be noted that [REDACTED] is seven years of age and while speaking to her, it was clear to me that her intelligence level is commensurate with her age. The following is a synopsis of [REDACTED]'s digitally-recorded, sworn statement: [REDACTED] advised she is seven years of age and visiting Disney World with her family. She is staying with her family at the Animal Kingdom Lodge. On today's date, she was spending the day at the pool with her family [REDACTED] advised she was in the pool with her goggles on and was swimming by an older man with gray hair. She went under water and noticed his "private" was out of his swim shorts, which she described as "blue, white, and red shorts." I asked [REDACTED] what she meant by his "private" and she advised it was his "bathroom part." I asked [REDACTED] what comes out of the "bathroom part" she saw and she advised "pee." [REDACTED] advised the bathroom part was "in the middle and kind of on the side" of his shorts. She thought there was a hole in the shorts and he had no shirt on. [REDACTED] advised she swam

away from the man, but he began to follow her and she got "scared." She swam further away, but he followed her. [REDACTED] got out of the pool and went to her parents. She told them she saw a man's "bathroom part" and he was following her and she was scared. [REDACTED] advised they heard another family talking about the same thing and they all began talking. She did not know the other family and this was the first time she met them. A copy of [REDACTED] digitally-recorded interview was put on compact disc and placed in evidence. On June 11, 2012 at approximately 1712 hours, I conducted a sworn digitally-recorded interview with [REDACTED], father of [REDACTED]. This is a synopsis of the digitally-recorded interview [REDACTED] advised he is staying with his family at the Animal Kingdom Lodge. His wife called him over earlier and told him their daughter [REDACTED] had told her she saw a man's privates. He asked her who the guy was and [REDACTED] turned around and noticed a male with red, white, and blue striped swim trunks in the middle of the pool. He was tan and had "grayish" hair. [REDACTED] heard another couple behind them talking about the same thing so he began to watch the male. He wasn't sure if it was a misunderstanding so he wanted to watch him for a while. [REDACTED] noticed the male "float around to other girls with goggles." When they would go under water, the male would stand in front of them with his hands up in the water. He went to different parts of the pool and [REDACTED] then noticed him swim towards his daughters again. He called his daughters out of the pool and kept watching him. The male swam to other young girls with goggles on in the pool. [REDACTED] became angry about what he was seeing, so he told the lifeguards what was going on. Within a few minutes a manager came to [REDACTED] and asked him what was going on. The male was still in the pool and [REDACTED] was still watching him. The male would crouch into the water and then slightly stand up when the girls would go under water. He swam to two young girls with goggles on and [REDACTED] advised the girls went under water and came up giggling. The male was standing directly in front of these two girls. [REDACTED] noticed the girls go under water again and pop back up. The girls were giggling going "oh my god, oh my god" and calling a young boy over telling him he needed to see this. At this point the male noticed everyone was looking in his direction and got out of the pool. A copy of [REDACTED] digitally-recorded interview was put on compact disc and placed in evidence. Witness Tyler Anderson provided a written statement that included the following: The witness stated he is a lifeguard for Animal Kingdom and he was approached by a male ([REDACTED]) telling him another male was exposing himself to young girls at the pool. He began to watch the male in question and noticed him approach two girls in the pool and stand in front of them. The male's back was turned away from the witness but he noticed the two girls had goggles on. They went under water and came back up. The girls were facing the front of the man, whose back was to the witness. He noticed the girls come up from being underneath the water and they were looking at each other with a "concerned look." They went back under water again and came back up. They looked at each other and "appeared more concerned." They went under the water a third time and when they came back up, one of the girls called for her mom as "though she was scared." She called for her mother "multiple times." A little boy swam up to them and the girls were pointing at the man. The man then exited the pool. The witness' statement will be included in the packet. [REDACTED], parents of victim 2 [REDACTED], and [REDACTED], parent of victim 1 [REDACTED] will prosecute and testify in court. The male was stopped by Disney Security at this time and was identified as John Oldham through his New York Drivers License. The deputies then arrived on scene and met with security. On June 11, 2012 at approximately 1730 hours, after my investigation was concluded at the Animal Kingdom Lodge, Oldham was secured and transported to Central Operations located at 2500 West Colonial Drive. On June 11, 2012 at approximately 1610 hours, an interview was conducted with John Oldham. He was read his Miranda rights from a preprinted card by myself and invoked his rights. On June 11, 2012 at approximately 1846 hours, Crime Scene Investigator Arthur Rubart (3700) responded to the interview room at Central Operations to collect and take photographs of the swim shorts that Oldham still had on under his pants. I inspected the swim shorts for any damage. The swim shorts were red, white, and blue in color. Each color was in a horizontal stripe on the swim shorts. The inside of the swim shorts had built in underwear that was intact. There did not appear to be any damage to the shorts and I did not see any holes in the shorts. The shorts were collected by Crime Scene Investigator Rubart and will be placed in evidence. Taking the victim's and witness' statements into consideration, PROBABLE CAUSE exists to ARREST John Oldham for two counts of Lewd or Lascivious Exhibition in violation of Florida State Statute 800.04 (7) (a).
