NARRATIVE: The undersigned has probable cause to believe the above-named defendant on the, 21 of April 2013 at 1:54 AM at 400 W CENTRAL BLVD (Zone: D5) in Orange County did

On 4-21-13 at approximately 0155 hours Sergeant VanWagner (8938) was parked at the intersection of N Hughey Ave and W Central Blvd when he heard a loud argument. Sgt VanWagner turned and saw a white male and white female walking west bound on Central Blvd while the male yelled fuck you several times. As Sgt VanWagner approached he saw the white male, later identified as James Knepper, take off his shirt and throw it down. Knepper then walked towards the white female, later identified as [REDACTED] and push her while they stood facing each other. Sgt VanWagner then approached placing Knepper in handcuffs pending further investigation.

Upon my, Office Payne (16301), arrival on scene I met with two security guards who were working at the Federal Court House at the time of the incident. Both provided sworn written statements. I first spoke with Troy Jenkins. Jenkins stated he heard Knepper yelling, "Fuck you Fuck you" as he walked down the sidewalk with [REDACTED] stated he saw Knepper walk in front of [REDACTED] and take off his shirt. Jenkins stated he then saw Knepper push [REDACTED] with one hand [REDACTED] did not fall to the ground.

Next I spoke with Maston who stated he and Jenkins were walking west on W Central Blvd when he heard and saw a white male (Knepper) yelling fuck you at a white female [REDACTED]. Maston stated he then saw Knepper take his shirt off and push [REDACTED] Matson stated [REDACTED] did not fall to the ground.

I then spoke to [REDACTED] who stated she and Knepper were arguing when she pushed him [REDACTED] stated that because she pushed Knepper he pushed her back [REDACTED] stated she did not want Knepper to be arrested.

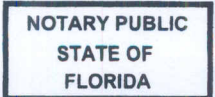
Officer Tran (18824) was the first to speak to Knepper. Knepper initially told Officer Tran [REDACTED] punched him the face and that he pushed her away. I then went to speak with Knepper. I read Knepper his Miranda rights, Knepper stated he understood and decided not to speak with me about the incident.


Photos were taken [REDACTED] and she was provided a victim's rights booklet. Neither [REDACTED] nor Knepper had any visible injuries. Based on the witness statements Knepper is the primary aggressor. Knepper and [REDACTED] have been dating for four years and live together as a family making their relationship domestic in nature. Knepper was arrested and charged with domestic battery. He was transported to jail without incident.

A check of IRIS revealed nothing was captured on video.
