#### SCPD WARRANT ROUND-UP - OPERATION SUMMER SWEEP

In an effort to combat illegal narcotic activity within the city limits of St. Cloud, the St. Cloud Police Department's Investigative Services Division conducted a warrant round-up, Operation Summer Sweep, on Friday, May 17, 2013.

Two (2) residential search warrants were served; 246.4 grams of marijuana as well as one thousand nine hundred twenty-eight dollar (\$1,928.00) were seized, resulting in sixteen (16) felony arrests. There are a total of five (5) felony suspects still at large.

All sixteen (16) arrestees have been transported to the Osceola County Jail. 
