On February 10, 2014, the Sanford Police was requested to respond to 1320 Oleander Avenue Apt. C Sanford, Seminole County, Florida in reference to a possible missing child. Upon arrival, contact was made with Andre Carson (witness). Andre Carson advised, that he was advised, by a black female only known to him as Tonya that she assisted Rachel Fryer, black female, date of birth 24 June, 1981 (arrestee), dispose of Rachel Fryer's deceased child in Crescent City, Florida at a known location.

On 10 February, 2014 at about 1130 hours, I, Investigator Erwin made contact with Ms. Rachel Fryer in the lobby of the Sanford Police Department. Rachel Allein Fryer disclosed that on Thursday 6 February, 2014 at about 0900 hours, she received a home visit by Community Based Care caseworker Jonathan Irizarry. Rachel Allein Fryer further stated that Jonathan Irizarry observed all her children and that only her oldest child was awake and left for school. After Jonathan Irizarry left the residence, Rachel Allein Fryer woke the remaining three children to find the child victim, Tariji Gordon, black female, date of birth 6 March, 2011, unresponsive.



Sanford Police Officers, Agents from the Florida Department of Law Enforcement and Deputies of the Putnam County Sherriff's Office responded to 117 Madison Avenue Crescent City, Putnam County, Florida and located the shallow grave with a small child's shoe exposed. The shoe was consistent with that of the footwear described by Rachel Allein Fryer. Also, located nearby in the woods, was the leopard patterned suitcase that was used to transport the child victim. The scene was secured pending the issuance of a search warrant for the residence and curtilage of 117 Madison Avenue, Crescent City, Putnam County, Florida. On Tuesday, February 11, 2014, the child victim was exhumed and transported to the Medical Examiner's Office in St. Johns County for the purpose of autopsy and the determination of cause and manner of death.

Rachel Allein Fryer's three surviving children were transported to Kid's House of Seminole County and forensically interviewed by CPT Amy Robertson and found that the oldest child,

On 10 February, 2014, Sergeant Jason Shor of the Sanford Police Department made contact with Audrey Dennis, Mother of the child's Father, Timothy Gordon and paternal grandmother of the child victim. Audrey Dennis provided law enforcement with two cellular phones belonging to her, that she allowed her son Timothy Gordon to use. These phones had received either text messages or phone calls in the immediate past from Rachel Allein Fryer, from phone number and the following was found: '

On Tuesday, 11 February, 2014, Mr. Timothy Gordon Jr. arrived at the Sanford Police Department and advised that on Wednesday, 5 February, 2014, he did in fact stay the night at 1320 S. Oleander Avenue apartment C Sanford, Seminole County, Florida with Rachel Allein Fryer and the child victim Tariji. Timothy Gordon continued that the child victim, Tariji, soiled her pull-up and due to this, Rachel Allein Fryer spanked the child victim and made the child victim stand in a corner for about an hour and then placed the child victim on the potty. At one point during the night, he woke up to find the child victim standing up against a wall with her arms "Ace Bandaged" over her head. Timothy Gordon corrected Rachel Allein Fryer and made her remove the bandages. Timothy Gordon continued that at just after 0600 hours, on Thursday, 6 February, 2014, Timothy Gordon woke up to Rachel Allein Fryer pushing the child victim onto the floor with the child victim striking a step. Timothy Gordon fed the child victim some leftover Orange Chicken and left the residence a short time later and reports that the child victim was on the potty.

At about 1617 hours on Monday, 10 February, 2014, I, Investigator William met with Jonathan Irizarry, dependency case manager for Community Based Care (CBC). He advised that he was in fact the case manager and he conducted a home visit at the residence of 6 February, 2014 at about 0700 hours. Upon contact with Rachel Allein Fryer he sat on the futon and discussed the case plan with Rachel Allein Fryer and at the same time he observed all four children in the residence. Mr. Irizarry advised that the oldest child and watching TV, dressed and ready for school. Mr. Irizarry continued that he observed and Tariji sleeping on the futon and heard them snoring and was asleep in her room. Mr. Irizarry advised that he physically checked all the children and stated that he heard the child victim, Tariji, snoring and observed her open her eyes. Mr. Irizarry advised that he did look at the child victim's legs, arms and face and did not observe any marks/injuries. Mr. Irizarry did not observe any marks/injuries to any of the other children.

On Wednesday, 12 February, 2014 I attended the Autopsy of the child victim. The Medical Examiner, Dr. P. Bulic advised that the child victim died from blunt force trauma to the head resulting in a large bleed on the right side of the brain. The child victim presented multiple injuries in various stages of healing to include bite marks that have been linked to Rachel Allein Fryer. Dr. Bulic ruled Tariji Gordon's death as a homicide.

From this investigation, I, Investigator William Erwin have found that Rachel Allein Fryer, did in fact commit the offense of Homicide While Engaged in Certain Felony Offenses, F.S.S. 782.04 (1)(a)2, Aggravated Child Abuse with great harm F.S.S. 827.03 (1)(a), Evidence Destruction/Tampering F.S.S. 918.13.(1)(a) and the Public Order Crime of Mishandling Dead Human Body/Remains F.S.S. 497.386. Rachel Allein Fryer intentionally abused Tariji Gordon with the intent to harm her and as a direct result inflicted injuries severe enough to cause Tariji Gordon's death. And whereas, Rachel Allein Fryer known as the primary caregiver, parent, adult household member, or the person responsible for the child victim's welfare, Tariji Gordon, black female, date of birth 6 March, 2011, child under the

age of 18 years, did fail or omit to provide Tariji Gordon with the care, supervision, and services necessary to maintain the child's physical health including but not limited to medicine and medical services that a prudent person would consider essential for the wellbeing of the child and based on a single incident or omission that resulted in the serious physical injury or a substantial risk of death to the child and it resulted in a great bodily harm, permanent disability to the child and was disclosed by the surviving children. Rachel Allein Fryer did in fact have the ability to contact emergency services and as a direct result, without such services, Tariji Gordon died from the inflicted injuries. After Tariji Gordon's death, Rachel Allein Fryer by her own admission

and statements of witnesses. Rachel Allein Fryer did in fact improperly dispose of human remains by placing Tariji Gordon's body in the rear of 117 Madison Avenue, Crescent City, Florida.
