• Upon review of the substation surveillance video, Officer Delio delivered a knee strike to Liese's abdominal area. Officer Delio entered the room, and immediately approached Liese when he delivered the knee strike. The knee strike occurred as Liese was in the process of sitting down, and verbally stated twice that he was doing so. Officer Delio referred to Liese as an "asshole," "scumbag," and "shithead" during the incident. Sergeant Michael Faulkner "disapproved" of Officer Delio's "techniques and tactics" during this incident, and concluded that the use of force by Officer Delio was not in compliance with OPD guidelines and training.
